- c. The unit should have GST enrollment and valid Trade License etc.(upto date)
- d. Affidavit regarding non black listing of the unit.
- e. Manufacturers/Bonafide Supplier should have supplying/working experience with Govt. Organisation/ Public sector undertaking/Private Enterprise/Private Hospitals & Nursing Home for last three years in the relevant field.
- f. Supplier /Manufacturer will be empanelled after inspection of premises by competent authority.

3. Terms & Condition:

Conditions for empanelment:

- a. The vendors shall be enlisted for a period of three years
- b. The enlisted suppliers are ordinarily exempted from furnishing earnest money deposit with their tenders (Limited Tender)
- c. The names of the qualified suppliers shall be displayed on www.tacospin.in
- d. The enlisted vendors shall be classified into four categories on the basis of Turnover, Customer satisfaction, Quality of work and Performance. On the basis of which supply order will be issued and attachment with the organisation will also be reviewed periodically.
- e. The manufacturing units who have "ISO Certification" will also get preference if other condition is fulfilled by them. Certificate to be enclosed.
- f. Supplier empanelled in certain category of material/ service should not be allowed to participate in tender for other category of material/service.
